In case of any cancellation, the following rules apply:

From Tour Start Date,

* For cancellations made up to 91 days in advance, 30% of the prepayment will be deducted and the remaining balance will be refunded.

* For cancellations made between 90 - 60 days, 30% of the tour fee is deducted and the remaining balance is refunded.

7. TERMS OF CONDITIONS

a. Changing the Boat

When J-Dalış is not able to fulfil its commitment because of unforseen reasons with OKYANUS

JD may change the boat to fulfil its commitment.

b. Cancellation of tour / Interruption of Tour

If by reason of force majeure, J-Dalış may cancell the tour and terminate the aggrement.

J-Dalış commits repayment of remaining days to charterer if the breakdown, collision, grounding lasts more than 48 hours or agreement can not be fulfiled with another ship. Other requests by the CHARTERER will not be accepted. J-Dalış is a Turkish company and all the diasgreement regarding reservation and contract will be brought to Turkish court and will be solved according to Turkish law.

a. **Responsibilities**

J-Dalış is responsible to fulfil the services committed on the web page. <u>www.okyanusblueyachting.com</u>

J-Dalış's responsibility covers aboard, J-Dalış is not responsible for the activities before tour starts and after tour ends. J-Dalış transfers its guests who wish to be transfered with a trustful transfer company.

J-Dalış has right to cancel the contract if charterer exeeds the guest capacity referred on this aggreement.

It is charterer / parents responsibility if children are taken on board.

No pet is allowed onboard.

Non of the guests disturbs other guests / vicinity or damage the J-Dalış and OKYANUS JD reptuation. J-Dalış has right to cancel contract of guest/guests who continue to act against all the warning.

Carriage and usage of drugs is probhited according to Turkish Law. Bringing weapon is not allowed.

Smoking is probhited in Salon and cabins and on the cushions. Damage to material and cushions is at the charterer expense. Please ask smoking areas to captain.

8. Insurance

OKYANUS JD has been in insured by a Turkish insurance company and covers her passengers. Our insurance covers onboard accidents which happens during the cruise (P&I). Ship insurance doesn't covers any accident happend out of OKYANUS JD boat. We kindly advice our

guests to make insurance against; accidents which can happen out of ship, health, cancellation of tour, loss of luggage and interruption of tour.

9. Force Majeure

J-Dalış is not responsible of any cause of accidents, events, happenings which are out of control – force majeure, act of God- and will effect negatively the tour organisation such as war, terrorism, strikes, weather conditions, fire, flood, poverty, major mechanical or electrical breakdown, airport reorganisation or closing, unforseen program change of mass transportation such as flights or ship cruises or any schedule change of transportation.

10. Pandemic

If charterer have to cancell the tour because of a pandemic J-Dalış accepts back payment of received amount just after receiving official document from charterer.

10. Complaints

J-Dalış has to be informed in advance about any kind of complaints during the tour. Complaints has to be given written to J-Dalış within 21 days. J-Dalış takes no account of complaints given 21 days after tour ends.

Since our aim is to estabilsh satisfaction of our guests, we consider any advice or comment about us and our tours.

11. Health, Sport and Diving/Training (During Dive Liveaboard)

Our guests who attend to dive liveaboard tours approve that they are healty for the cruise, sport activities and diving/training.

It is kindly adviced all divers are medically examined before the tour starts. All the divers apply to Turkish Underwater regulation and signs up "Agrrement of Dive Tour."

In case divers refuses obeying the diving rules, J-Dalış keeps the right of cancellation of tour and refusing refound.

Divers inform J-Dalış about their certification levels during the booking or before the tour starts.
